



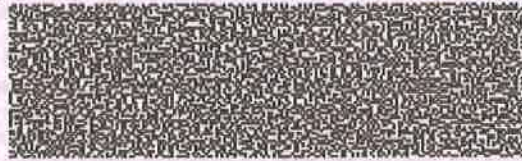
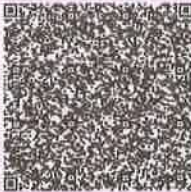

1. That the National Institute of Unani Medicine, Bengaluru shall not offer any programme(s) in the distance mode after its declaration as a deemed to be university.
2. That the National Institute of Unani Medicine, Bengaluru is a not-for-profit organization and shall not be engaged in commercialization of higher education.

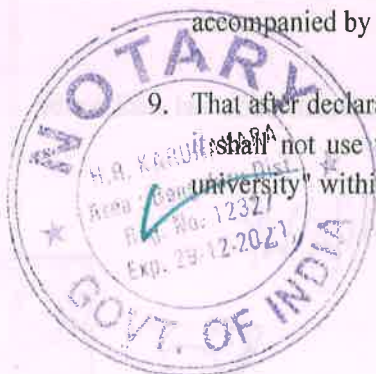

3. That the National Institute of Unani Medicine, Bengaluru have not violated any of the provisions of any of the statutes/guidelines of any Statutory Authority in the period of five years preceding the date of submission of the application seeking status of a National Institute of Unani Medicine, Bengaluru deemed to be university.
4. That hostel accommodation shall be gradually increased to at least 25% of the students within 3 years of existence of institution deemed to be university.
5. That from we undertake to submit undertaking from the funding society i.e. Ministry of AYUSH, Govt. of India to the effect that on being declared as National Institute of Unani Medicine, Bengaluru deemed to be university, the National Institute of Unani Medicine, Bengaluru shall continue to receive the funds for maintenance and developmental expenditure, including the salary and non-salary increases in expenditure and the future expansion.
6. That on being declared as National Institute of Unani Medicine, Bengaluru deemed to be university under the UGC Act, the National Institute of Unani Medicine, Bengaluru shall admit students to its approved academic programmes, under its enrolment, only from the academic session subsequent to the notification issued by the Central Government and enrolment of students to the National Institute of Unani Medicine, Bengaluru for any reason whatsoever, in anticipation of the declaration as National Institute of Unani Medicine, Bengaluru deemed to be university or inclusion of the National Institute of Unani Medicine, Bengaluru under the ambit of as National Institute of Unani Medicine, Bengaluru deemed to be university, shall render the application invalid.
7. That the income and property of the National Institute of Unani Medicine, howsoever derived, shall be utilized only for the promotion of the objectives of the National Institute of Unani Medicine, Bengaluru including its growth and development. No portion of the income / property of the National Institute of Unani Medicine, Bengaluru shall be paid or transferred, directly or indirectly by way of profit, to the persons who were /are members of the National Institute of Unani Medicine, Bengaluru, provided that nothing herein contained shall prevent the payment in good faith or remuneration to any member thereof or to any other person in return for any service rendered to the National Institute of Unani Medicine, Bengaluru or for travelling, halting and other similar charges, and all such expenditure shall be appropriately reflected in the accounts of the National Institute of Unani Medicine, Bengaluru maintained for the purpose
8. That the professional programmes already being conducted by it, if any, have the approval of the relevant Statutory/Regulatory bodies like AICTE, MCI, DCI, NCTE, BCI, INC etc., along with a duly attested copy of the letter of approval granted to it by such bodies. In addition, each application shall be accompanied by an essentiality certificate from the State Government concerned, wherever necessary.
9. That after declaration of the National Institute of Unani Medicine, Bengaluru as Deemed to be University, shall not use the word 'University' suffixed to its name but may mention the words "deemed to be university" within parenthesis suffixed thereto.
