The terms and conditions:

- 1. The firm has to mention the charges including GST.
- 2. The firm has to submit the copy of GST registration certificate.
- 3. The firm has to submit the copy of Pest Control license certificate.
- 4. The firm may visit the Institute to check the above areas before quoting.
- 5. The validity of quotation shall be one year from the date of first order to the L1.
- 6. Chemicals should be used properly for the above-mentioned services.
- 7. Repeat service shall be done by the firm if the concerned service is not satisfactory.
- 8. No extra payment shall be made for repetition of services.
- 9. Charges shall be quoted as per the frequency of service mentioned above.
- 10. All products/material/chemical used for providing the above service should be authentic.
- 11. For delay in completing the schedule of the above services during the period the following penalty shall be imposed.
- 12. For delay of five days during the service period -10% of the billed amount
- 13. For delay of 6-10 days during the service period -15% of the billed amount
- 14. For delay 11-15 days during the service period 20% of the billed amount
- 15. For delay 16-20 days during the service period -25 % of the billed amount
- 16. The above services should be provided properly. If the service is not upto the mark the contract shall be cancelled immediately and no payment shall be made by this institute.
- 17. The successful firm shall submit the 10% amount as security deposit by means Demand Draft in r/o Director, NIUM based on the rate quoted by the firm and shall calculate to Per annum for its security deposit towards providing the above services.
