## Sub: Inviting Re-quotations for Supply of Chemicals and Reagents to Hospital Lab- reg.

## Sir,

NIUM, invites sealed quotation from the dealers dealing with the Chemicals, Reagents & Glass ware Items for supply of the same to our Hospital lab by the reputed companies.

The authorized dealers are requested to quote the maximum discount allowing on MRP for supply of the above items for a period of One year on the following terms and conditions.

- 1. The rate quoted should be for one year from the date of acceptance of quotation
- 2. The firm should be a authorized dealer to sell the items (They should enclose authorization letter/certificate)
- 3. The firm should mention the Vat/Tin No. properly
- 4. The firm should supply the items to Institute within the stipulated time as mentioned in the supply order
- 5. Delay in supply of the chemical, reagents and glass wares Penalty shall be imposed as below For delay up to 5 days from the last date for supply 5% of the billed amount For delay up to 6-10 days from the last date for supply 10% of the billed amount For delay up to 11-15 days from the last date for supply 15% of the billed amount For delay up to 16-20 days from the last date for supply 20% of the billed amount. For delay more than 21 days 25% of the billed amount
- 6. While supplying the items the firm has to submit the delivery challan for the items supplied and obtain the initial of the Biochemist/Pathologist for the items supplied within the stipulated time and produce the same to office on the same day.
- 7. The items should be supplied F.O.R institute.
- 8. The firm is wholly responsible for the chemicals, reagents & Glass wares damaged at the time of transportation & packing
- 9. While using the chemicals, kits if any defect/damaged is found appropriate amount will be deducted in the bill and appropriate action will be taken in this regard.
- 10. The firm should deposit EMD money of `25,000/- (Twenty Five Thousand Only) along with the quotation by means of Demand Draft drawn on any nationalized bank favoring "NATIONAL INSTIUTE OF UNANI MEDICINE, B'LORE" Payable at Bangalore (Firms who have already deposited EMD earlier should submit the fresh EMD along with the quotation).
- 11. After quoting the rate of discount if the firm fails to supply the items due to reason what so ever the institute shall procure the items from outside/other agency and difference amount shall be deducted from the EMD/bill while making payment.
