Séaled quotations are invited for the supply of crude and Drugs mentioned in the list on or before **14.03.2018** with the following terms and conditions:

- Items should be supplied F.O.R NIUM institute.
- Payment will be made based on the actual quantity of items/drugs received at the time of the delivery.
- The items should be supplied within the stipulated date as mentioned in the supply order.
- If the items are not supplied within time and supplied within 15 days from the last date, then 5% of the billed amount will be deducted. If the items are supplied after 15 to 30 days from due date than 10% of the billed amount will be deducted.
- After 30 days from the due date the order will automatically treated as cancelled.
- The time beyond 30 days needed by the firm will not be accepted in any condition and no correspondence will be entertained by the institute with the firm.
- Firms may quote taxes applicable, if any, separately, failure to which it is presumed that the rates are inclusive of all taxes.
- The firms may mention clearly in the quotation the time required for supply of items from the date of supply order. In case the firms are not mentioning clearly the time required for supply of Crude Drugs, then the time given by the institute shall hold good for all the purpose.
- All the firms should submit their GST certificate copy with the quotations.

The envelope containing quotations should be super scribed as “**Re Quotation for supply of crude Drugs for Research work of PG students**” on or before **14.03.2018**.

Note: The firms submitted their quotation in response to the previous quotation dated 30.01.2018 need not apply again.


